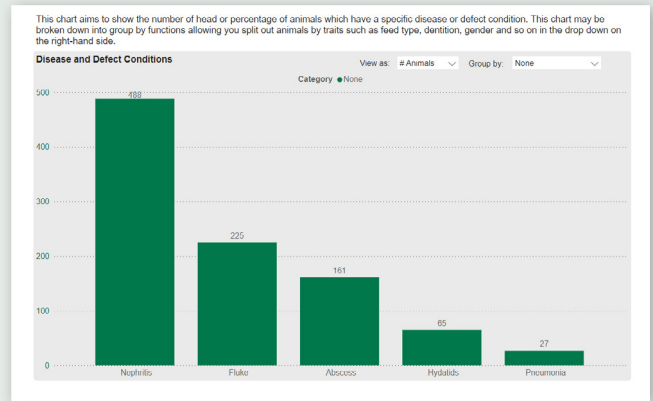
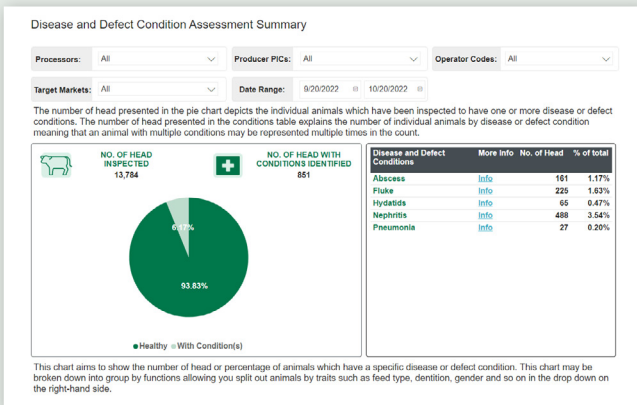
Animal Disease and Defect Report

1 Disease and Defect Condition Assessments

Summary: The number in the pie chart depicts the individual animals identified to have one or more disease or defect conditions. The conditions table demonstrates the individual animals by disease or defect condition. Animals with multiple conditions may be counted more than once.

This can be filtered by processor, PIC and date range.

2 Disease and Defect Conditions: This chart aims to show the number or percentage of animals with a specific disease or defect condition.

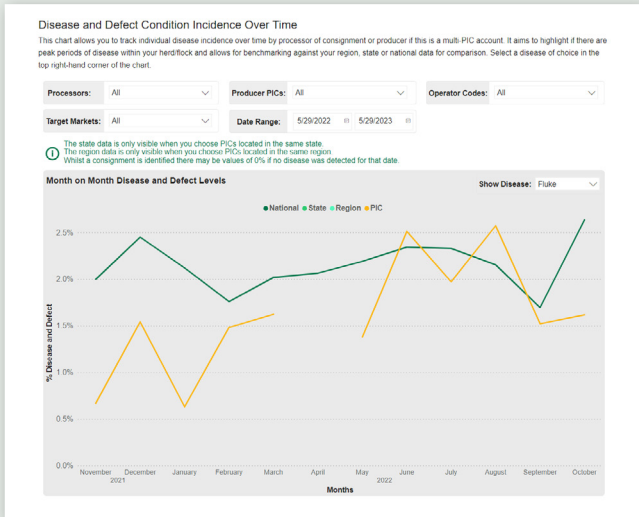


3 Disease and Defect Condition Incidence Over Time:

Track individual disease incidence over time by processor of consignment or producer/s. It aims to highlight if there are peak periods of disease within your herd/flock and allows for benchmarking against your supply chain, state or national data. Select a disease in the top right-hand corner of the chart.

Filter using the drop-down options. The chart can be further filtered by disease.

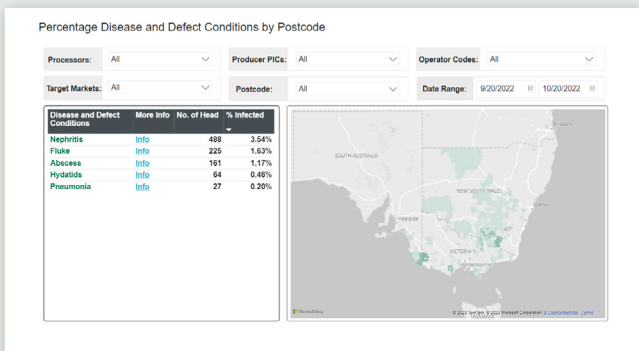
Individual PIC results are shown ● against national ● state ● and supply chain ● benchmarks.



4 Percentage Disease and Defect Conditions by Postcode:

Filter using the drop-down options. Select 'Apply Filter'.

The table will display results of the different types of diseases, number of head affected and percentage infected, based on the filters selected at the top of the chart. The heat map will show different colours for peak postcodes for disease and/or defect conditions. The darker the colour, the higher the incidence in that postcode.

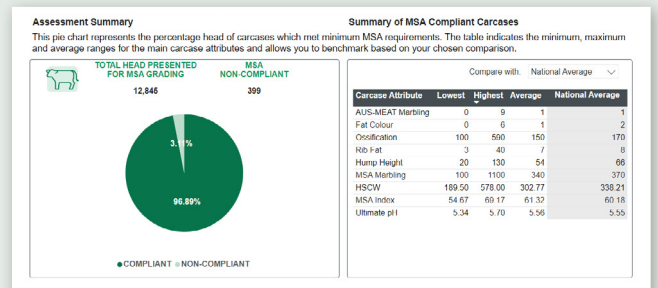
1 Filter the items from the drop-down menus and select 'Apply Filter' to view the results.

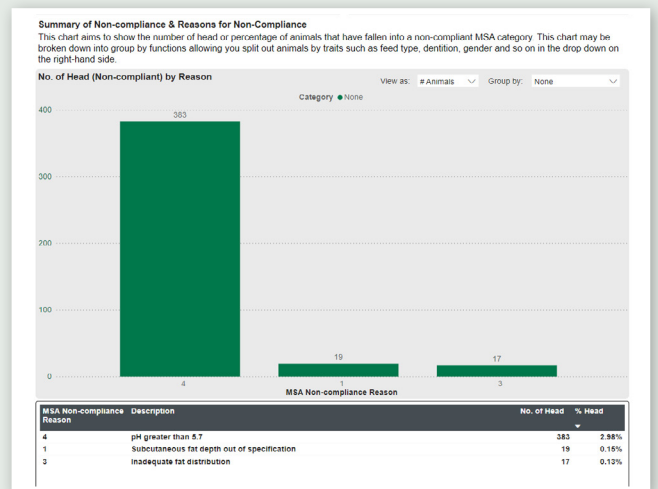
Compliant Carcasses: This demonstrates the percentage of carcasses meeting minimum MSA requirements. The table indicates the minimum, maximum and average ranges and allows you to benchmark against traits.

Filter to compare against National Average, Own Supply Chain or State Average, by selecting from the drop-down menu.



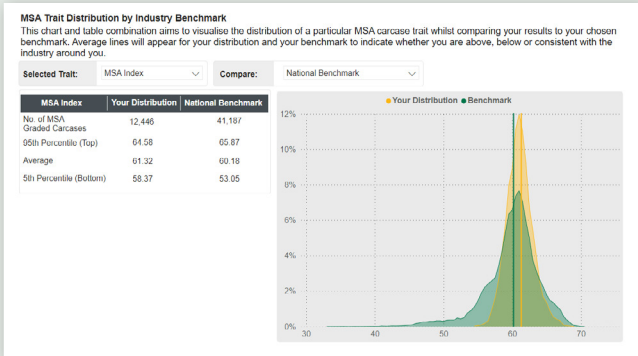
3 Summary of Non-compliance & Reasons for Non-Compliance:

This chart aims to show the number or percentage of animals that have fallen into a non-compliant MSA category. Group by functions to split out animals by traits.



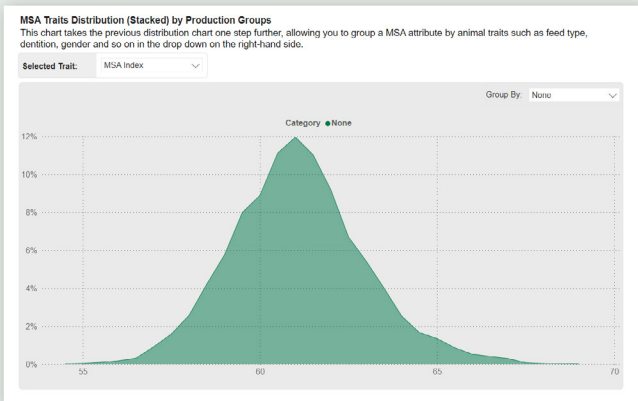
4 MSA Trait Distribution Compared to Industry:

These graphs help visualise the distribution of a particular MSA carcass trait against a chosen benchmark. Average lines will appear for your distribution and your benchmark.



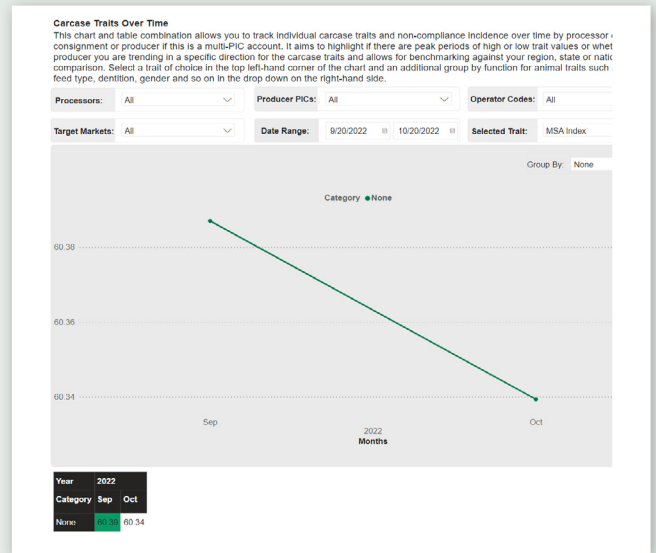
5 MSA Traits Distribution by Production Groups:

This chart enables you to group an MSA attribute by animal traits such as feed type, dentition, gender and so on in the drop down on the right-hand side.



6 Carcass Traits Over Time:

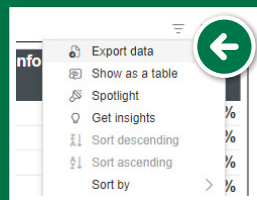
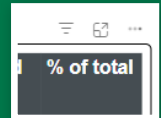
Track individual carcass traits and non-compliance incidence over time by processor or consignment or producer/s. It aims to highlight peak periods of high or low trait values or carcass trait trends and benchmarking against supply chain, state or national data. Select a trait in the top left-hand corner of the chart and group by function for animal traits in the dropdown on the right-hand side.



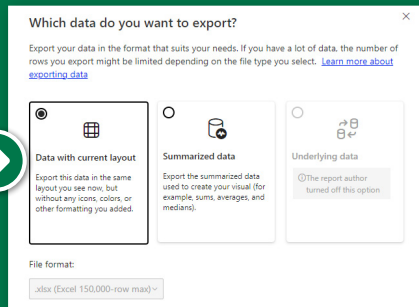
Download data

To download any of the data in the myFeedback system:

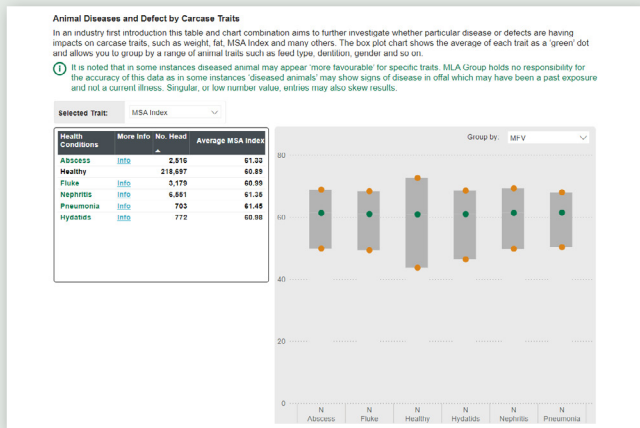
1 Animal Diseases and Defect by Carcase Traits:

Investigate whether particular disease or defects are having impacts on carcase traits. The box plot chart shows the average of each trait as a 'green' dot and allows you to group by a range of animal traits.

In some instances disease animals may appear 'more favourable' for specific traits. Singular, or low number value entries may also skew results.

MLA Group holds no responsibility for the accuracy of this data as in some instances diseased animals may show signs of disease in offal which may have been from past exposure and not a current illness.

The graph can be filtered by grouping by traits such as gender, dentition or ossification. Select from the 'Group by' drop-down menu to change the view.



2 Carcase Traits by Disease and Defects

This table shows the number and percentage of head by disease and/or defect conditions with average traits represented for the data selected as per the filters at the top of the report page.

3 Correlation between Traits and Diseases:

This chart aims to show the relationship between selected traits and disease incidence. A bubble will appear for each disease and/or defect and will be sized according to the number of head in the data. You will have the ability to assess diseased vs. healthy animals based on a range of carcase and MSA traits.

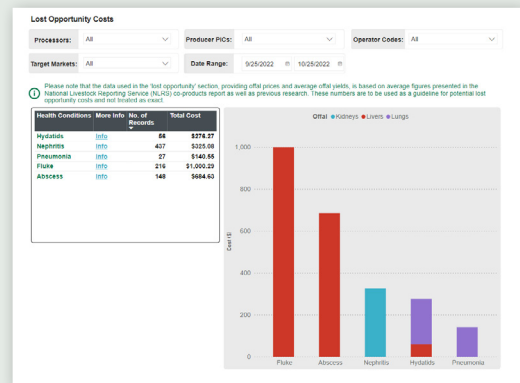


4 Lost Opportunities Costs

In this section, you can view co-products (offal pricing) data based on national averages from the National Livestock Reporting Service (NLRS). This can be filtered by processor, PIC, operator, target market and date ranges.

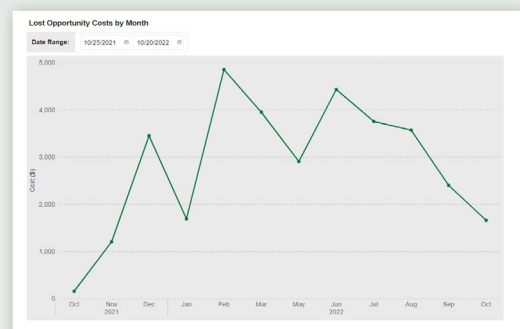
Please note that the data used in the 'lost opportunity' section, providing offal prices and average offal yields, is based on average figures presented in the National Livestock Reporting Service (NLRS) co-products report as well as previous research. These numbers are to be used as a guideline for potential lost opportunity costs and not treated as exact.

This section provides critical average information based on the lost opportunity cost associated with a disease and/or defect condition leading to condemnations of offal items.



5 Lost Opportunity Costs by Month:

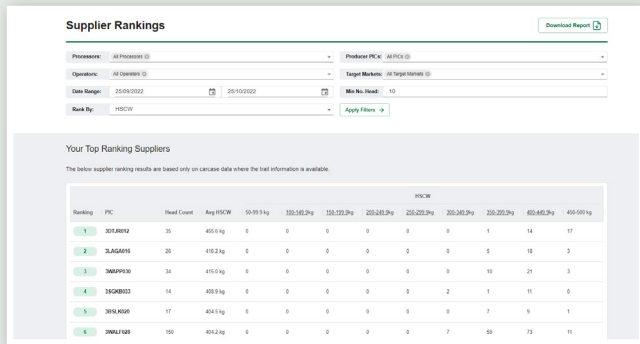
Select the date ranges in the drop-down menus to update the graph and track lost opportunity costs over time.

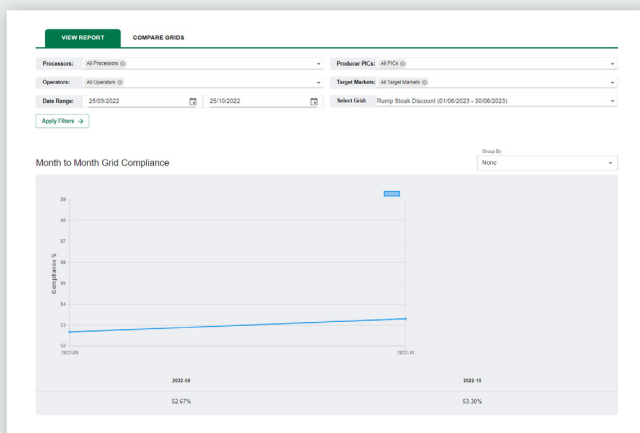
- Sort the data by selecting the arrow next to each column header.



Compliance to Grid Report

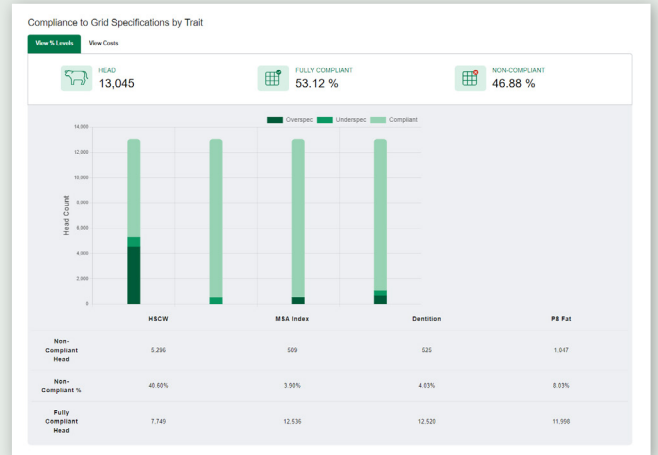
Compare individual livestock by filtering by processor, PIC, target market, operator, date range and grid.

- Month to Month Grid Compliance:** The filters at the top of the report will determine the data shown on this chart. You can further refine this by selecting from the 'Group by' drop-down.

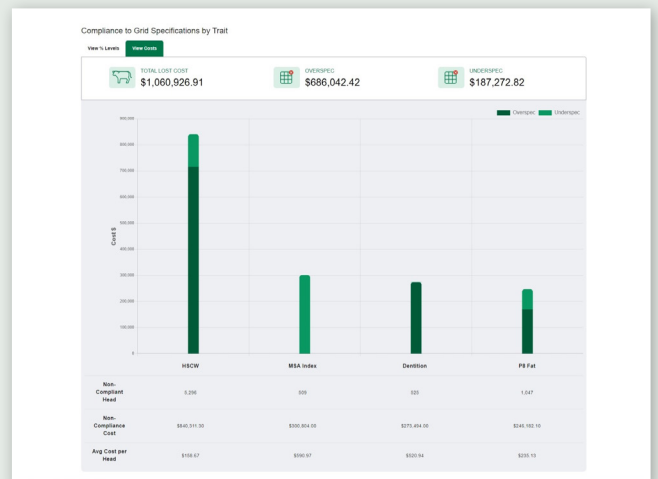


2 Compliance to Grid Specifications by Trait:
