Abstract

The main activities and achievements over the last 12 months have involved the Redlands for Regions project and providing secretarial and technical support to the new Executive Officer. The long-term financial future of The Leucaena Network will depend on increasing membership and securing external funding assistance. Improved availability of Redlands seed along with animal production data should see a significant expansion in Leucaena plantings. The future of Leucaena will be assured when a sterile variety of Leucaena is commercially available.

Executive summary

The role of secretariat took on more focus during 2017 when there was a change over from one Executive Officer to the next. This was an important period where new funding models were being developed and the Redlands for Regions project was in its initial stages.

During this period, the secretariat supported the Executive Committee in appointing a new Executive Officer, kept up to date with administration duties and communicated on a regular basis with Meat & Livestock Australia.

A summary of activities and achievements appears later in this report.

The future of The Leucaena Network will depend on continued membership and external funding, the promotion of the Redlands variety and if a sterile and productive variety can be developed.
